General Requirements:

1. I agree that all work shall be performed by a licensed contractor, (license number _____), unless waived by the Design Review Committee.
2. No work or commitment of work will be made by me until I have received written approval from the Design Review Committee.
3. All work will be done at my expense, and all future upkeep will remain at my expense.

4. I assume all liability and will be responsible for all damage and/or injury which may result from performance of this work. I also agree to provide the Association with a Certificate of Insurance, naming the association as an additional insured, as proof of the contractor's liability, auto, and workers' compensation coverage.
5. I agree that the work must be completed within the approved construction time frame and must be done in a way that does not unreasonably interfere with or inconvenience other unit owners. Failure to meet the completion date may subject me to a fine of \$50 per day until the work is completed satisfactorily.
6. I will be responsible for the conduct of all persons, agents, contractors, and employees who are connected with this work.
7. I will be responsible for removing in a timely manner any debris resulting from construction.
8. I will be responsible for complying with and will comply with all applicable federal, state, and local laws, codes, regulations, and requirements in connection with this work, and I will obtain any necessary governmental permits and approvals for the work. I understand and agree that the Association, its Board of Directors, its agents, and the committee have no responsibility with respect to such compliance, and that the Board of Directors or its designated committee's approval of this request shall not be understood as making any representation or warranty that the plans, specifications, or work comply with any law, code, regulation, or governmental requirement.
9. I agree that any misrepresentations of any items in this request, either oral or written, may void any approval by the committee.
10. I understand that a decision by the committee is not final and that the Board of Directors may reverse or modify a decision by the committee upon the written application of any owner made to the Board of Directors within 10 days after the committee makes its decision.

12. I agree that any work not started on or before the proposed start date may be subject to resubmittal to the committee.

Specific Requirements:

1. An applicant desiring to install a washer and dryer in the unit must supply, with this application, architectural drawings to be submitted to the County for an installation permit. All electrical, plumbing, and fire safety codes must be met at the time of construction. No plumbing for drains is allowed on the exterior of the

building, whether encased in wood or any other type of chase. All plumbing must be installed within the existing exterior walls, so as not to make any change to the appearance of the building. The applicant is responsible to include the removal, reinstallation, and necessary painting of siding by the contractor.

I have read the Design Review Committee requirements. The applied for changes or additions meet the requirements and standards specified by the Design Review Committee and all applicable federal, state and local laws and regulations.

I acknowledge and agree that approval by the Design Review Committee does not constitute an opinion regarding the safety of the proposed alterations or their consistency with federal, state or local laws and regulations. I further agree to indemnify and hold harmless the Association and its successors, agents and assigns, from any liability occurring as a proximate result of the alterations herein contemplated.
